For scientific employment position - research associate in the area of the interdisciplinary field of science (geography, economics) - permanent contract - 1 employee, 20 hours per week

Mandatory requirements for the position: Applicants must meet the requirements stipulated in article 41 paragraph 2 of the Act on Scientific Activity and Higher Education and the conditions prescribed by the Ordinance on additional conditions for selection for scientific positions available on the Institute's website (<http://www.iztzg.hr/UserFiles/file/institut/o-nama/PRAVILNIK-O-DODATNIM-UJVJETIMA-ZA-IZBOR-NA-ZNANSTVENA-RADNA-MJESTA.pdf>). In addition to the above-mentioned requirements, excellent computer skills (Windows environment and associated standard programs), as well as good knowledge of English and Croatian in speech and writing are needed.

Preference will be given to candidates with experience in conducting, coordinating and/or participating in scientific and expert projects in the fields of: management of the marine environment and resources, and anthropogenic impacts of tourism (nature and environmental conservation) and with experience of participating in EU projects and writing scientific papers from the above-mentioned fields (measured by impact factor).

Applicant for the position, in addition to a written application, need to enclose:

1. Curriculum vitae with a list of scientific and professional publications
2. Copy of the PhD diploma
3. Copy of decision of the promotion to the academic grade
4. Evidence of fulfillment of the conditions prescribed by the Ordinance on additional conditions for selection for scientific positions
5. Proof of work experience (electronic record of data recorded in the database of the Croatian Pension Insurance Institute).

The Institute reserves the right to conduct interviews, test knowledge and skills for registered candidates who meet the formal requirements.

Persons of both sexes may apply under equal opportunities.

Applicants who are entitled to the right of priority to employment pursuant to article 102 of the Act on Croatian Homeland War Veterans and Members of their Families and who, at the moment of application meet the conditions required to exercise this right, are obliged to attach in addition to their application and all other evidence required by the job vacancy, the proof of meeting the mentioned requirements for the right of priority to employment. The application deadline is 30 days from the date of the announcement of the job vacancy in the Official Gazette. Applications submitted after the deadline and applications without evidence of requirements needed will not be taken into consideration.
